#### AFFIDAVIT

#### WHEREAS:

- PLAINTIFF: I am known by name as Sovereign Hereditary Siam/Chief: Kiapilano<sup>TM2</sup>, Creditor, Surety, Agent acting in full capacity as Author of the Trademark Copyright Autograph for CHIEF ©CAPILANO4 in any style of cause. I am the gatekeeper of the West for the Pacific coast of my Squamish™ Nation Lands and Natural Resources on lands known in Admiralty/Maritime jurisdiction as corporations "BRITISH COLUMBIA" and "CANADA". I have personal knowledge of the matters and facts hereinafter and do HEREBY ATTEST THAT:
- As the eldest, surviving male of my father, George-Johnston: Capilano™ and Sovereign head of the ©Squamish<sup>TM</sup> Nation, the 'royal' hereditary DNA of my Family Name runs through my body, mind and spirit as Sovereign Hereditary Chief Kiapilano™. As the Sovereign Hereditary Chief of the Squamish™ Nation Lands and Natural Resources, I declare my right, position and title as a sovereign man of natural inheritance from my natural grandmother, Josephine: Capilano™ to name my father, George-Johnston: Capilano™ in her Last Will and Testament of September 20, 1923.
- From the John Bouvier's Revised Sixth Edition, 1856 A Law Dictionary, "Once JURISDICTION: jurisdiction is challenged, the court cannot proceed when it clearly appears that the court lacks jurisdiction, the court has no authority to reach merits, but, rather, should dismiss the action". Melo v. US, 505 F2d 1026. I claim Common law jurisdiction understood by the Europeans as natural laws of the land for the people by the people and laws of the SquamishTM Nation longhouse laws by estoppel by Final Order and Equitable Remedy by Estoppel.

Sovereign is a state of being higher than "Royalty" defined by colonial European language. I have below me over 200 hereditary Chiefs in right of claim on Turtle Island Together as all Hereditary Chiefs and Landlords of these Lands, we stand as strong spirits and souls like, arrows in a bunch that can not be broken despite the many years of abuse and agenda of genocide orchestrated by the Governments who operate from alien jurisdiction.

The title of my Name is not clear as INAC crossed my Family Name out of history books to deliberately provide lies about my True Heritage and genealogical claims to the

Squamish Mation Lands. As a True member of the Red Race, the word "chief" does not exist because the "white race" has created this title to make True Red Originals from the Lands believe the Corporate Elife from alien jurisdiction words that steal, kill my people and destroy our Squamish Nation Lands and the future for our children. History proves that the Corporate Elite will continue with this destruction until the True claims of the Red Race are issued, spoken, felt, heard and seen. The Word 'Siam' is closer to the true correct traditional description title of my Family Name.

As Names are changed so are hereditary claims to the lands, stolen from the true landlords of the Lands. Until the Landlord wakes up and claims his/her rightful heir to Title from the Trustees, the Queen of ENGLAND and the King, HOUSE OF THE ROTHSCHILD. My claim of my True Family Name by a notarized Statutory Declaration served by registered Notice #247-613-620 to INAC and other Civil Servants in service to CORPORATIONS BRITISH COLUMBIA AND CANADA on December 19, 2007. This legacy is what my great grandparents left for me, my children, grandchildren and the future of my Squamish™ Nation people. My responsibility is to make sure that our customary laws will always be respected and protected. Our Nation's tradition to drum is to offer the rhythm of the ocean as Earth's heart beat and so we give thanks to the food that nurtures the spirits and souls of all living things. I have a big responsibility to protect this Squamish<sup>TM</sup> Nation Territory, her animals and natural resources for the future of seven generations by defending the Squamish™ traditional lifestyles to be sovereign/tax free and right to free travel, customary laws from being violated and disrespected by individuals who do not respect our customs. As we honor our self governance over the ancient teachings of self healing medicines, the right to hunt, to fish, to speak in our Squamish™ language and travel freely. No one has a right to take my Family name without my written consent as our customary laws are meant to live in harmony on this Land with each other in the Name of Friendship. It is when individuals living in our community who violate and disrespect our customs, that the spirit of peace is broken. Despite written Evictions and Registered Notices to stop the genocide against my people and stop privatizing Mother Earth's natural resources, the crimes from alien jurisdiction Bonded administrators continue. This country and numerical geographic code is used for the Bank Credit financial name of ©Universal Sovereign Squamish Bank Credit Group<sup>TM</sup> (©USSBCG<sup>TM</sup>). USSBCG<sup>TM</sup> adopts the Bills of Exchange Act described herein as its Charter pursuant to Common law jurisdiction and Squamish<sup>TM</sup> Nation longhouse laws which are supreme to Admiralty/Maritime jurisdiction as it operates in truth pursuant to the CANADA Evidence Act (a).

Allied Irish Banks p.l.c. is regulated by the Financial Regulator, Registered Office: Bankcentre, Ballsbridge, Dublin 4, Ireland, its Bill of Exchange Act definition is simple and easy to understand, therefore its adopted as the Charter to USSBCG<sup>TM</sup>:

"A Bill of Exchange is one of the key financial instruments in International Trade. The laws regulating Bills of Exchange in different countries come under two different legal spheres of influence:

- → Bills of Exchange Act (1882) United Kingdom

The Bill of Exchange is defined under these systems as follows:

Bill of Exchange Act (1882) - United Kingdom

"A Bill of Exchange is an unconditional order in writing, addressed by one person to another, signed by the person giving it, requiring the person to whom it is addressed to pay on demand or at a fixed or determinable future time a sum certain in money to or to the order of a specified person, or to bearer".

Convention providing a uniform law for Bills of Exchange and promissory notes (Geneva, 1930) The League of Nations.

Under Article 1 of the above convention a Bill of Exchange must contain:

- The term "Bill of Exchange" inserted in the body of the instrument and expressed in the language employed in drawing up the instrument.
- 2. An unconditional order to pay a determinate sum of money.
- 3. The name of the person who is to pay.
- 4. A statement of the time of payment.
- 5. A statement of the place where payment is to be made;
- 6. The name of the person to whom or to whose order payment is to be made;
- 7. A statement of the date and of the place where the bill is issued;
- 8. The signature of the person who issues the bill.

The Parties to a Bill of Exchange - definitions:

- The Drawer Is the party that issues a Bill of Exchange in an international trade transaction; usually the seller.
- (2) The Drawee Is the recipient of the Bill of Exchange for payment or acceptance in an international trade transaction; usually the buyer.
  - (3) The Payee Is the party to whom the Bill is payable; usually the seller or their bankers.

Most countries have adopted codified laws on Bills of Exchange. The legal codes in such countries have created laws that follow the rules agreed at the Geneva Conventions in order to standardize the control of Bills of Exchange. The United Kingdom Bills of Exchange Act 1882 is the basis for rules governing Bills of Exchange in Ireland, U.K. and Commonwealth countries that were part of the British Empire. These countries follow a common law framework to create and modify statutes.

In relation to the most fundamental aspects of a Bill of Exchange the two sets of rules are similar in that both identify the following:

- 1. A Bill of Exchange is an unconditional order to pay a specific amount of money.
- 2. The Bill of Exchange must state a particular time of payment.
- 3. The Bill of Exchange must contain the name of the person who is to pay.

There are, however, certain differences between the Bills of Exchange Act (1882) and the Geneva Convention. In particular the United Kingdom Act sets out fewer formal requirements for example:

The term "Bill of Exchange", which is an integral part of the physical Bill according to the Geneva Convention, need not be written on the Bill.

- → Bills can be made payable to 'bearer'.
- ★ The place and date of issue are also not obligatory parts of the Bill.

The United Nations Commission on International Trade Law (UNCITRAL) is at present trying to harmonize the laws.

The function of the Bill of Exchange in International Trade;

- 1. Facilitates the granting of trade credit in a legal format by permitting payments on agreed future dates.
- 2. Provides formal evidence of the demand for payment from a seller to a buyer.
- Provides the seller with access to finance by permitting them to transfer their debts to a bank or other financier by merely endorsing the Bill of Exchange to that bank or financier.
- Permits the banker or financier to retain a valid legal claim on both the buyer and the seller. In certain
  circumstances a bank or financier may have a stronger legal claim under a Bill than the party that sold them
  the debt.
- 5. Permits a seller to obtain greater security over the payment by enabling a bank to guarantee a drawee's acceptance (guarantee to pay on the due date) by signing or endorsing the Bill. (See Guaranteed Bills of Exchange below)
- Allows a seller protect their access to the legal system in the event of problems, while providing easier
  access to that legal system.

The Bill of Exchange in international trade: A Bill of Exchange can either be payable immediately or at some future date;

- → If a Bill is payable immediately, it is usually issued payable at sight. The term "at sight" means that a buyer should pay once they have sighted the Bill, that is once the demand for payment has been made.

Guaranteed Bills of Exchange: To provide greater payment security a seller may look to have a Bill of Exchange guaranteed by USSBCG<sup>TM</sup>. A guaranteed Bill of Exchange is one drawn on and accepted by the buyer and to which, the buyer's bank has added its guarantee that the Bill will be paid at maturity. The security to a seller comes from a bank giving an undertaking to effect payment on a certain date regardless of the financial standing of a buyer on that date.

Financing Options with Bills of Exchange: The ability to negotiate or discount Bills of Exchange can be an extremely important source of finance in international trade. The Bill of Exchange can provide easier access to financing because it enables the financing bank to retain a claim on all parties to the Bill. In addition parties that finance Bills of Exchange can, in certain circumstances, obtain stronger rights than the party transferring the Bill to them. Bill discounting may provide access to finance rates lower than the overdraft or loan rate the seller could normally obtain.

Negotiation Facilities: The negotiation of a Bill is the transfer of the rights under a Bill from one party to another for value. Some banks will negotiate Bills for a customer by purchasing Bills from them for value. For example, the bank credit will advance 75% of the face value of the Bill and upon receipt of the proceeds will clear the advance together with any accrued interest on the advance. Negotiation facilities can be used to finance Bills payable at sight or Bills payable at a future date even before they have been accepted. Negotiation facilities are normally granted with full recourse to the seller.

Bills Discounting with recourse: Discounting of a Bill of Exchange can only occur once the Bill has a definite maturity date in the future and the buyer has accepted it. Discounting differs from negotiation in that the

bank will calculate the net present value of the face value of the Bill utilizing a cost of funds interest rate and a margin. The net amount so calculated is then advanced to the seller. Upon receipt of the proceeds from the buyer at maturity, the bank will clear its Bills discounted account. This finance is provided with recourse to the seller by the bank.

Bills Discounting without recourse: Similar to with recourse Bills Discounting, except that the financing bank will waive its rights of recourse to the seller. This can occur when the Bill is guaranteed by another bank, or where the buyer has a very strong credit standing or rating.

12. The USSBCG™ system is backed by 'true' value of contracts to credit the Family Name of Irene-Maus: Gravenhorst™, President of USSBCG™. Irene presented her contracts to give value to the real estate belonging to Royal Hereditary Chief Kiapilano™ of the Squamish™ Nation government pursuant to the Bills of Exchange Act. RHCK™ accepted the value of the contracts and monetized them by attaching the contracts to the real estate of the Squamish™ Nation lands. Furthermore, the natural resources of the lands on Squamish™ Nation territory present an additional security to the contracts that back the new hard lawful currency UTPC™. The proposed use of this new currency is reported to the UN and respective credit bureaus. Finally, Kenneth D. Lewis of the Bank of America is the Named Third Party Fiduciary Debt Holder to an MBNA contract issued on April, 2008 for \$7,812,756,075,252.48T UTPC™. Copies of additional contracts are available upon request.

#### Universal Right to Tax Free Travel

13. Pursuant to Article 36(1)(2) of the UNDRIP, the ISNSG™ will issue individual diplomatic passports for traveling to other continents. Peace Cards defined as a Passport / International Driver Permit allow individuals to tax free travel. Issued Licence plates for vehicles traveling on Turtle Island are protected with a lifetime Nine Trillion hard, lawful UTPC™ currency insurance coverage. Licence renewal information with the Squamish™ Nation Business Registry service is not required, unless it is surrendered voluntarily or returned due to criminal charges. The plates will indicate the transfer from Admiralty/Maritime jurisdiction to Common law and Squamish™ Nation longhouse jurisdiction by this Declaration are only issued to Squamish™ Nation members as presented in a version hereto;

#### **Business Location**

14. USSBCG<sup>TM</sup> will announce its physical location through an en masse internet marketing and advertising campaign to communicate to the general public on line that there is competition for old banking methods. People interested in a 'bank credit' card chartered by the IBOE / BOEA and Common law jurisdiction must complete a form in order to meet set standards and qualify as an account holder.

#### Account Holders

15. We respect free will and enforce the Privacy Act and Trespass Act [RSBC 1996] Chapter 462. No third party is permitted to garnish, close accounts or place liens against named account holders without the written consent from the account holder at USSBCG<sup>TM</sup>. We will not violate the Nuremberg Principals, UN Declaration on the Rights of Indigenous People or the Declaration of the Human Rights, 1948 accordingly we ask our account holders to respect these international treaty laws.

The Account Holders will be provided with a bank credit card that bears the photograph and autograph of the account holder. The black strip will contain transfer of value of the credit data from one account to another in exchange for the purchase or return of products and/or services. 
